4) Faith In Action report –Irvin reported on the last leadership committee for the transportation group, which was mostly a recap of the transportation program in Charlottesville, which members felt might serve as a model. Key features are small vehicles and coordination so that citizens could request transportation a day ahead of time and have door-to-door transportation at the time requested. Irvin noted that the next meeting would be on December 12<sup>th</sup>, which he would be unable to attend due to a conflict with the monthly Democratic Party meeting.
